I. CALL TO ORDER

Brian Snell called the meeting to order at 6:04p.m.

II. MINUTES OF PREVIOUS MEETINGS

The Board has reviewed eight sets of meeting minutes. They recommended a few minor grammatical amendments.

Ross MOVED to approve the minutes of the following meetings as amended: March 24, 2025, May 27, 2025, and June 9, 2025 and also to approve the minutes of the following meetings as presented: February 10, 2025, February 24, 2025, April 7, 2025, April 16, 2025, May 12, 2025. Snell SECONDED. Motion CARRIED by roll call vote. Snell – aye, Ross – aye, Genovese – abstained.

III. APPEARANCES

a. Charter/Spectrum's failure to serve all despite assurances

Ross has no update at this time. The Board would like to leave this as a standing item on future meeting agendas until the issue is resolved.

b. Richmond Road Auto/junkyard and incomplete vehicle zoning violations – update

Young received an email from Building Commissioner, Brian Gale. Gale indicated that he has not received any further complaints. There are fewer junk vehicles at the property but still a lot of vehicles there. The Board would like to leave this as a standing item on future meeting agendas until the issue is resolved.

Snell requested Young's retirement and work status on each agenda going forward as well.

c. Chapter 268 Section 20C an 20D Ethics disclosures or exemptions

There is discussion regarding someone that was elected to the Library Trustees and also works at the library. Genovese explained if you are appointed to a position and then you are elected for a conflicting position, but during the election process there is full disclosure that you are already serving on a Board or Commission and they still choose to elect you, that is enough disclosure. Young indicated that it is good practice to give notice to the Town Clerk and Ethics Commission regardless.

Young indicated the Board should discuss their strategy going forward in supporting the School Committee on the home rule petition to obtain some sort of resolution to the school choice issue. b. Selectboard Report

Ross indicated that the Town Forest Committee has discussed the red pines on Wendell Road/Hockanum Road and will come up with some resolutions/actions to get rid of them.
